Chapter 18.04 – ZONING DISTRICTS

This chapter establishes provisions for zoning districts and the uses that are permitted within the various zoning districts. It also includes the minimum lot sizes, maximum building heights, setbacks and other dimensional standards for development within each zoning district.

City staff is proposing clerical corrections and other clarifications throughout the chapter that are not substantive to the administration of the code provisions. The purpose of this document is to summarize substantive changes that are being proposed.

Chapter 18.04 – [USE] ZONING DISTRICTS

The chapter title is being changed to "Zoning Districts," which reflects common terminology as well as terminology used in the enabling provision in NRS Chapter 278. The map creating the districts is a "zoning map," therefore the districts it creates are "zoning districts."

The corresponding Master Plan land use designations are added to the purpose statements for each zoning district.

Use Tables

The following pages contain the changes to the permitted use tables for each zoning districts. It shows all uses that are being deleted, added, combined with other uses, or where uses are being permitted in different zoning districts than they are currently permitted.

Deleted use terms are indicted by stricken (stricken) text, and added text is in **bold-underlined** text. Staff notes or explanations are in [bracketed text].

Many use terms have a similar meaning to other use terms and are combined in many instances to minimize the number of individual uses listed. For example, a "coin store" is a "retail" use, so it is redundant to include "coin store" in the list of uses. In this example, staff notes that the term is being deleted and combined with the term "retail," which reads in the tables as: Coin store ["Retail"]. Refer to the term "retail" to see in which zoning districts the use is permitted.

See the complete use tables to determine if a specific use is listed as permitted, conditional or prohibited.

Note: An "accessory structure" is permitted within any residential zoning district. The use of the structure, e.g. for "farm" equipment, depends on the zoning of the property on which the accessory structure is located. "Accessory farm structures" are currently exempt from size limitation per provisions in CCMC Chapter 18.05. It is proposed to eliminate that exemption for residential districts and treat all accessory structures the same.
